Course Information

Course Objective: The objective of this course is to have students thoughtfully engage with Dr. Paul Kalanithi's Pulitzer Prize Finalist memoir "When Breath Becomes Air". Students should gain an appreciation for Dr. Kalanithi's vulnerable contributions and deep reflection by actively engaging in reading and discussions. Reflect on the meaning of the work in relation to the fragility of life and the pain of terminal illnesses. Observe Dr. Kalanithi's priorities towards the end of his life, and how our own priorities might change in the event of such news.

Attendance and Participation

Reflections

Students will be asked to complete two reflection assignments on the content of the book halfway through the semester, and after the last class period. Students are expected to thoughtfully reflect on what they have taken away from the material and class discussions.

Final Project

Students will present a final project during their last two class periods. This project can be done in assigned small groups of 4. The project will be relatively open-ended, and students will be expected to draw connections between themes in the book with another work of art (song, movie, poem, art piece, book, etc.). This will be presented to the class with some prepared material to show. Students may also opt to be creative, and create their own interpretations of the meaning of the book and what they took away from it. This could be a painting, a poem, mixed media, there are many ways to go about this project. Students will be graded on their effort and depth of understanding that is portrayed from their work.
