Course Description/Faculty Experience:

In this Uncommon course, students will have the opportunity to engage in-depth depictions of reemergence of research and practice into the use of psychedelics across the American healthcare system. In particular, this course will consider the efficacy advocated for by the author Ido Hartogsohn. The class group will have weekly opportunities to share observations from the reading and discuss positions or opinions in relation to the book's arguments and descriptions.

Student Learning Outcomes

- 1. Develop multiple approaches to an analytical engagement with non-fiction texts.
- 2. Develop a more dynamic understanding of the US Healthcare system and the social stigma associated with treatment methodologies including psychedelic therapy.
- 3. Learn of the pitfalls to access humane treatment for substance use disorders and other issues more commonly associated with expanded mental healthcare including PTSD and Depression.

Grading/Examination/Attendance

This course will meet for one hour weekly. Chapters assigned per week will be outlined on the syllabus schedule. Students are expected to attend the weekly meeting and to provide a short verbal presentation/ response to the content of that week's assigned chapters. There are no examinations for this course, however weekly commitments to the reading will include 2-3 hours weekly (meaning that each student needs 2-3 hours of time to read the assigned chapters weekly). Grading will be based on weekly participation in the class meeting including providing a short verbal presentation. Therefore, attendance weekly and preparation by reading the assigned chapters is essential for a successful completion of the course. Missing class will result in losing points for that date. Excused absences, meeting the DSO requirements, will be honored.
